The Chairman welcomed all members and informed about the reason for calling this emergent meeting. At the outset, Chairman congratulated the Pharmacy Department for celebrating the Diamond Jubilee function of the Department and for conducting 2 days National Seminar, Alumni Meet and signing of 12 MoUs with the Industries, Research Institutes and Universities on this occasion. He mentioned that this is landmark achievement of signing 12 MoUs together in the history of the University. He placed on record the achievements made by the Department under the leadership of Prof. Ashmita Gajbhiye, Prof. Sanjay Kr. Jain and Prof. S P Vyas and the tireless contribution made by one and all in the department and others to make the event success.

Subsequently, the minutes of  $9^{\text{th}}$  emergent meeting were read and which were confirmed by the APC. Thereafter, the agenda was taken up.

EX:APC:01: Eligibility criteria of Supervisor for Ph.D.

Resolution: The matter shall be dealt in accordance with the relevant Ordinances and

Skunh 17/116 stipulations made therein.

EX:APC:02: Determination of number of Ph.D. seats, reservation and advertisement thereof.

**Resolution:** The APC resolved that the number of seats in each Department shall be determined as on the date of advertisement and shall be communicated to the Admission Cell through the DPGC/BoS. The reservation policy of the Government of India shall be followed *mutatis-mutandis*.

EX:APC:03: Matter relating to Admission Cell for Admission 2016-17.

**Resolution:** The APC after deliberation, approved the Admission Brochure for the session 2016-17 with the following amendments:

- That apart from the existing Centres there will be additional centres in other States; Palakkad (Kerala) and Visakhapatnam (A.P.) and Mandla, Burhanpur and Neemuch in the State of Madhya Pradesh.
- 2. The Entrance Test fee for UG and PG shall be revised from Rs.600 to Rs.800 for General/OBC/PwD candidates and from Rs.300 to Rs.400 for SC/ST candidates. The Entrance Test Fee for Ph.D. shall be revised from Rs.900 to Rs.1000 for General/OBC/PwD and from Rs.450 to Rs.500 for SC/ST candidates and MP online portal fee of Rs.50. If a candidate wants to amend entries in his/her application an additional fee of Rs.20/- shall be paid by the candidate as portal fee to the MP online limited.
- Relaxation/Weightage/Reservation shall be applicable to the wards of ex-service personnel, candidates with NCC/Sports etc. certificates, as per provisions of the Ordinances and norms of the Govt. of India.
- Candidates having ATKT in any semester shall not be granted admission at the time of counselling.
- 5. Provisional admission shall only be given to those students who are awaiting last year/semester examination result. Such students will have to submit their result latest by 30<sup>th</sup> September of the admission year, failing which their admission will stand cancelled automatically and fee paid by him/her shall stand forfeited. No representation shall be entertained at any level.
- Only GPAT qualified candidates subject to validity duration mentioned in the card are eligible for admission to M. Pharma. Only GPAT qualified candidates shall be eligible for admission to Ph.D. in Pharmacy.

 As per the UGC letter No.F1-27/2009(SCT) dated 09-09-2015 and MHRD letter No.F.No.14-5/2013-SC/ST dated 13-01-2014;

Clause No.3 (i) "No fees need be charged at the time of admission from those SC/ST students who are eligible for Post-matric Scholarships/Top Class Scholarships. At the time of admission they may be advised to deposit the fee with the Institute as soon as they receive the Scholarship amount. An undertaking to this effect may be taken from them at the time of admission. However, the CFHEIs will be responsible for timely verification, etc. of documents and their submission to facilitate timely disbursement of scholarship".

- 8. There will be separate papers for entrance test for MA (Sociology) and Master of Social Work.
- Candidates seeking admission to B.Lib & In.Sc. must have 50% marks at UG level also. Relaxation as applicable shall be given to the candidates of respective categories.
- 10. Admissions under the DASA scheme of the Ministry of HRD shall be given on supernumerary basis for which the matrix to the Nodal agency i.e. NIT Srinagar shall be provided separately by the Co-ordinator DASA.
- 11. Ph. D Entrance Test shall be held along with the UG and PG entrance test.

EX:APC:04: Validity of admission of Shri Rahul Khare, a student of LL.B, session 2014-15.

Shri Rahul Khare was given provisional admission in LL.B. in the session 2014-15. Shri Khare was a student of B.Com from Arts and Commerce Boys College, Sagar and got B.Com passed with 2<sup>nd</sup> Attempt i.e. ATKT-2 in the semester Jan-June 2015 on 21-12-2015. On the basis of provisional admission in the session 2014-15, he appeared in the 1<sup>st</sup> sem examinations of LL.B and his result was declared on 27-02-2015. He has now requested to allow him to register in LL.B 2nd sem as a regular student.

Resolution:

After deliberation and in view of his completing the B.Com degree with 2<sup>nd</sup> Attempt i.e. ATKT-2 in the semester Jan-June 2015 result on 21-12-2015. His admission session being 2014-15, the APC resolved to cancel the admission of LL.B. Ist semester for the session 2014-15. Therefore, the result of Shri Rahul Khare of LL.B. 1<sup>st</sup> Sem. stands cancelled.

EX:APC:05: Continuance of Dr. Raghvendra Singh as Supervisor of Ms. Neha
