The Ministry of Human Resource Development, Government of India vide its letter No.C.30018/01/2017-CDN dated 31<sup>st</sup> May, 2017 had desired UGC to issue necessary advisory to all higher educational institutions (HEIs) that all monetary transactions of the educational institutions may be done using digital modes of payment under the National Digital Payments Mission (NDPM) of MHRD.

The UGC vide its letters D.O. No. 1-1/2017 (Secy) dated 06<sup>th</sup> June, 2017, 28<sup>th</sup> August, 2017 and D.O. No. 14-26/2018(CPP-II) dated 02<sup>nd</sup> November, 2018 had issued an advisory to all the HEIs requesting for implementing monetary transactions through electronic and digital mode to bring about transparency and propriety (**copy enclosed**).

In order to ascertain the effective use of digital modes in Universities and Colleges, the UGC is collecting online information. All universities and colleges are requested to submit the information of digital transaction on the University Activity Monitoring Portal (UAMP) of UGC at the following link <https://www.ugc.ac.in/uamp/>, for the financial year 2018 - 2019 (1<sup>st</sup> April, 2018 to 31<sup>st</sup> March, 2019) and first quarter of the financial year 2019 - 2020 (1<sup>st</sup> April, 2019 to 30<sup>th</sup> June, 2019) on the above link by using user ID and password provided by UGC latest by 16<sup>th</sup> August, 2019. The relevant instructions to the affiliated colleges/institutions of your esteemed university in this regard, may also be issued.
