## Criteria adopted by the committee for screening of the applications:

Keeping in view the qualification and experience prescribed for the post, the committee unanimously resolved the following principles to be followed while screening the applications:-

- 1. Teachers working as Deans, HoDs, Director (HRDC), Proctor, DSW, Administrative Directors etc. in the University System or Teachers working as Principals/Vice-Principals in the Colleges their experience will be counted as Educational Administration
- 2. 15 years of Administrative Experience will be counted towards post held in Group A positions and above like Assistant Registrar or equivalent position in GP 5400/-.
- 3. Only post qualification experience will be counted.
