The Screening Committee has found that **53 candidates** fulfil the eligibility criteria, as per the University advertisement No. R/A-NT/2019/001 dated 01/03/2019.

All those candidates who fulfil eligibility criteria based on working experience of reputed **Private Institutions** will have to produce a certificate from **Company Employer** having annual turnover of **Rs. 200/- Crore** certified by the concerned Competent Authority, at the time of Interview.

Since the number of the candidates who fulfil the minimum eligibility criteria is large, hence in order to downsize the candidates as per Recruitment Rules, **the committee unanimously recommends to conduct written examination for all the eligible candidates.**
